

**Quarterly Meeting Minutes of the Property Owners
July, August, and September 2022
Cape Carancahua Property Owners' Association
November 13, 2022**

Approval of the Minutes

Treasurer's Report – Charles Taylor

Mr. Taylor invited everyone to pick up a copy of the Profit & Loss Budget Performance report. Questions were asked by property owners about the extra accounts and Mr. Taylor explained they are in CD's and the accounts are fully funded.

Maintenance Report – Larry Schroeder

Mr. Schroeder invited everyone to take a copy of the quarterly maintenance report. There were no questions about the report.

Big stumps and palm trees were dumped at the Brush Pit during the night this weekend, therefore, the Brush Pit will be locked once again and the checked out at the office.

Garrett Medlin's last day in the Maintenance Department was Monday, November 7, 2022 due to him finding other employment.

Concern was mentioned about the drainage and culverts. Mr. Schroeder explained that the maintenance depart will see if they can clean out the culverts. The property owners need to ensure they are keeping the grass mowed around the culverts.

ACC and Noncompliance Report – Paul Warren

Eighteen building permits were issued during the third quarter of 2022 including one new home and one new manufactured home.

Non-compliance fees continue to be assessed when necessary to property owners who are in violation of CCPOA Deed Restrictions, Policies, and Regulations.

Legal Report – Robert Johs

The Cape's attorney submitted protests to Jackson County's Appraisal District in Edna for the 2022 property tax appraisals for all common grounds, etc. owned by the Cape. The Cape's

3. The purchasing of a laptop for the office was put on hold until further investigation.

2. Purchase of a laptop, new desk, and shelves for the office totaling no more than \$2,000 was approved at the board meeting today at 1:00 p.m.

Raised \$85,000 and hope to have the station expansions done in late spring. 911 signs are available at the office and fire station.
